How does it work?

To activate the device, the user will use his personal identification code (PIN). Once activated, the user simply chooses the one-time password or the e-signature application by pushing on the dedicated function button. Whether dynamic passwords are used to log-on to a restricted web site or e-signatures are created to sign a financial transaction, banks have greater control over who is trying to log-on or execute a transaction.

Intuitive User Interface

Digipass 270 Xpress was designed to enhance user-friendliness and user acceptance. Its keypad uses universally accepted icons and a simple graphic interface. Furthermore, Digipass 270 Xpress is extremely compact, making it ultra-portable for the end-user.
